## Edelman enters Africa through Baird's Renaissance

## African reach broadened

Tod Donhauser, currently executive vice president and head of the technology policy group in Washington, DC, will relocate to Johannesburg to become managing director, Edelman South Africa. He will report to Robert Holdheim, CEO, South Asia, Middle East and Africa (SAMEA). Peter Mageza, now deputy chairman of the board at Baird's CMC, will become vice chairman of Edelman South Africa.

With 20 full-time staff and 10 consultants, Baird's Renaissance has more than 20 years of experience in Africa, having delivered results in 29 of the continent's 55 countries. The agency's client roster spans the government, financial, telecommunications, health, tourism, energy and mining sectors.

"I am delighted that Baird and his team will soon be fully-fledged members of the group and that our clients will now receive a seamless service in South Africa and across the continent," said Brain.
