The objectives of this conference are:



- iv. to showcase newly established drug safety pharmacology infrastructure in southern Africa and to make efforts to identify shortcomings in expertise and infrastructure for addressing essential aspects of drug safety.
- v. to discuss career opportunities in drug safety will be discusse with pre- and post-doctoral students.


