Academically, Oye has a rich and diverse background. She holds an MBA from University of Manchester in the USA. On African soil, she has completed a bachelor's degree in commerce (B. Comm) as well as a diploma in education from the University of Cape Coast.

With her excellent organisational and management skills and practical knowledge of accounting systems, Oye will play a critical role in leading the profession in Ghana and supporting the global work of CIMA and the Association of International Certified Professional Accountants.
