The Law Society explains that it is important to have a professional draft your Will as "often a Will is not valid because the person who drafts it does not have the necessary legal knowledge to ensure that the requirements of the law are met. - 4. Family feuds often occur when family members argue over the distribution of your Estate if your final wishes are not clearly documented in a Will.
- 5. Winding up your Estate can take years without a Will appointing a professional executor, the government is essentially in control of the process.
- 6. You lose the ability to nominate a guardian of your choice for your minor children.
